NEWARK, NJ—The New Jersey Symphony Orchestra welcomes seven new members and three returning members to its Board of Trustees. ## **NEW AND RETURNING BOARD MEMBERS**

**Thomas Comiskey** is the New Jersey Regional President for M&T Bank, overseeing the middle market, commercial real estate, healthcare and not-for-profit commercial banking teams.

Comiskey began his career in 1993, holding multiple international marketing, corporate strategy and M&A positions for Amway Corporation and Mary Kay Cosmetics. During this time, he led culturally diverse cross-functional teams that developed a global telecommunications strategy and launched a \$100-million color cosmetics line in Japan.

Seiver graduated from the Curtis Institute of Music and received a Bachelor of Arts degree from Harvard University and a Master of Music degree from The Juilliard School.
