TERMS & CONDITIONS

On the advancement of payment, the payer acknowledges that he or she has read and understands the specific inclusions, exclusions, registration and cancellation policies of the bus trip, the terms and conditions listed below and that he or she agrees to be bound by them. Signature above authorizes payment to the New Jersey Symphony for all trip charges. This trip is sold as described, and New Jersey Symphony makes no refund for unused portions of the trip.

- Cancellation penalties may apply.
- Concert tickets are limited and available only to patrons participating in the trip.
- Full terms and conditions are provided to the NJ Symphony patrons prior to booking. After booking, patrons receive a confirmation.
- Expect a detailed itinerary at least one week before departure.

Agreements: Quoted trip prices include planning, handling and operational charges and are quoted in US dollars based on the current rate of exchange, tariff and fuel prices.

Responsibility: New Jersey Symphony and its operating partners purchase transportation, hotel accommodations, restaurant services and other services from various independent suppliers that are not subject to its control. New Jersey Symphony and its operating partners cannot, therefore, be liable for any personal injury, loss or damage to person or property that may occur due to (1) a wrongful, negligent or arbitrary act by others not under direct control of New Jersey Symphony and its operating partners, (2) defects in, or failures of, vessel, automotive vehicle or other means of transportation not under its control, or (3) acts of God. New Jersey Symphony and its operating partners also reserve the right to withdraw a trip or any part of it, to make such alterations in the itinerary as it deems necessary or desirable, to refuse to accept or retain as a member of any trip or part thereof any person at any time, and to pass on to trip members any expenditures or losses caused by changes, delays, or events beyond its control. New Jersey Symphony and its operating partners are not responsible for any expenses incurred by trip members in preparing for the trip, including non-refundable tickets, special clothing or other trip-related expenses.

Baggage: Baggage handling is at the traveler's risk throughout the trip. Baggage restrictions may apply.

Smoking: Smoking is not permitted during situations that involve fellow travelers. This applies when travelers are in restaurants, sightseeing vehicles, modes of transport and when participating in group activities.

Eligibility: All travelers should be in good health. Some venues on this trip do not have elevators. Some areas prohibit coaches, so walking is mandatory.

By forwarding the payment for this trip, the traveler certifies that he/she does not have any physical or other condition or disability that would create a hazard for him/her or others. It is essential that persons with any medical problems or related dietary restriction inform New Jersey Symphony well before departure.

Accommodations: Hotel accommodations for three nights are provided.

Meals: All breakfasts and dinners are included. Some lunches are provided where indicated.

Travel Insurance: New Jersey Symphony strongly recommends that travelers purchase travel insurance.

Prices: Prices are per person and based on a minimum number of 12 travelers. If fewer than the minimum number of travelers participates, a price supplement may apply and/or the itinerary may be adjusted.

Inclusions: Accommodations; arrival and departure group; ground transportation and sightseeing as indicated WITHIN Washington, DC; local wine and beer with included meals; hotel taxes; entrance fees to museums and places of interest as included in the program; gratuities for local guides and drivers; tour development and planning; reservations management by New Jersey Symphony; and preparation and delivery of preliminary and fiscal documents.

Exclusions: Personal expenses such as laundry and meals not listed, beverages (mixed drinks), room service, sightseeing listed as optional, transportation to Washington, DC, communication charges and personal insurance coverage.

Registration: Full payment is required at the time you book. Payment can be made by personal check, American Express, Visa, MasterCard or Discover.

Cancellations: No refunds will be provided for cancellations after March 1, 2024.
